Shoreline Trail Project

4.1 Presentation: Shashi Bandara, Project Engineer, Engineering and Operations

The Project Engineer gave a presentation on Shoreline Trail Sanitary Sewer and Trail Upgrades Project and the following was noted:

- the project includes the replacement of two sanitary sewers located parallel to the Canadian Pacific railway tracks:
- the project is multi-phased with both sanitary sewers scheduled for replacement or rehabilitation in the coming years;
- the available funding is for 30% design and funding strategies will be presented to Council for the design and construction phases; and
- the construction is scheduled to begin in February of 2021.

The Project Engineer requested feedback from the Commission to inform the design of the Project and the following was noted:

widen the entire trail;

- provide more rest areas;
- provide more signage to encourage people to move between Rocky Point Park and Old Orchard Park;
- install steel spans on the bridges;
- provide stroller access to playgrounds;
- provide connections to bike paths;
- provide weight bearing physical activities using environmental assets; and
- promote physical activity for children by providing opportunities such as Risky Play.

Staff noted the following in response to the Commission's feedback:

- the north side of the trail encompasses environmentally sensitive areas making widening the path challenging when attempting to strike a balance with usership and environmental values;
- the wayfinding work will be tied into the Joint Wayfinding Subcommittee work;
- the sanitary sewer budget cannot be used for trail upgrades;

- the railway crossings are being reviewed with Canadian Pacific to create secondary access;
- the lifespan of a new pipe is 75-80 years and about 50 years if trenchless or rehabilitated; and
- the addition of lighting poses environmental concerns and is not recommended as best practice in environmentally sensitive areas.

The Project Engineer left the meeting at this point and did not return.

Program

Invasive Management 4.2 Presentation: Lesley Douglas, General Manager, Parks and Environment

> The General Manager of Parks and Environment gave a presentation on Invasive Plant Management Program Update and the following was noted:

- the management of invasive plant species began 10-15 years ago and now includes species such as ants and beetles:
- the removal of plants generally occurs during the growing season;
- the Green Team brings people to the site and focusses on the removal of invasive species:
- the follow-up removal and restoration is a challenging area for local governments;
- the Plant Wise Program provides advice on plants you can purchase to replace where invasive ones were removed;
- the Invasive Plant Management training, education, and literature displays are provided at public events;
- the City hopes to hire an employee dedicated to working on invasive plant removal;
- the request for contribution of funds through development applications is included as part of a site's ecological plan;
- the training of staff to be cognizant of new species coming to the region is critical;
- the need for public awareness and education as well as resources is a major barrier; and
- the early detection and rapid response to these issues is critical to eradicating the invasive species.
