Subject: Lower Mainland Local Government Association Membership Renewal 2020

---

The Lower Mainland Local Government Association (LMLGA) is one of the five area associations of the Union of BC Municipalities (UBCM). It includes 33 local governments (from Pemberton to Hope) and three regional districts: Squamish Lillooet Regional District, Metro Vancouver, and Fraser Valley Regional District.

As indicated on their website, the LMLGA is a non-profit organization whose purposes are as follows:

- a) To represent, in one organization, the various regional districts, and local governments of the Membership Area, as defined in the Bylaws;
- b) To secure all possible united action in dealing with local government matters of interest to our members;
- c) To cooperate with other organizations dealing with matters under Provincial or Federal jurisdiction;
- d) To cooperate with the Union of BC Municipalities and other associations of municipalities in British Columbia for the advancement of the principles of local government;
- e) To secure united action among its members and to promote greater autonomy within local government;
- f) To acquire and distribute amongst the members, municipal information that may be deemed to be of value to members; and
- g) To hold meetings for promoting the aforesaid purposes

Each year, the City of Port Moody receives an invoice from the Lower Mainland Local Government Association for the membership. In 2019, the fees for the membership were \$1,839.00. For 2020, the annual fee is \$1,922.55, which is based on populations over 30,000 and under 60,000. This amount is already budgeted in Mayor and Council's Membership Dues and Boards budget. Should Council wish to renew the membership, the following resolution is recommended:

**THAT the City of Port Moody renew its membership in the Lower Mainland Local Government Association and remit the 2020 Annual Dues of \$1,922.55 as recommended in the memo dated July 6, 2020 from the Executive Assistant to Mayor and Council regarding Lower Mainland Local Government Association Membership Renewal 2020.**
