At the Regular Council meeting held on July 28, 2020, Council considered a report dated June 16, 2020 from the Planning and Development Department – Development Planning Division regarding Rezoning (RS1-S) – 1209 loco Road (Mr. Ahmad Moshri Fatemi) (**Attachment 1**) and passed the following resolution:

THAT City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 42, 2020, No. 3263 (1209 loco Road) (RS1-S) be read a first and second time as recommended in the report dated June 16, 2020 from the Planning and Development Department – Development Planning Division regarding Rezoning (RS1-S) – 1209 loco Road (Mr. Ahmad Moshri Fatemi);

AND THAT Bylaw No. 3263 be referred to a Public Hearing.

City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 42, 2020, No. 3263 (1209 loco Road) (RS1-S)—a Bylaw to amend City of Port Moody Zoning Bylaw, 2018, No. 2937 to allow for a small lot subdivision at 1209 loco Road—is the subject of a Public Hearing to be held on September 8, 2020. If referred from the Public Hearing, Bylaw No. 3263 (**Attachment 2**) would be before Council for consideration of third reading and adoption. The recommended resolutions are:
