## Discussion with Dr. Sarah Lubik

4.1 Dr. Sarah Lubik, Director of Entrepreneurship, Simon Fraser University

Dr. Sarah Lubik gave a presentation on Impact Hub 101 for Port Moody and the following was noted:

- the creation of clusters may begin organically or through the conscious collaboration of a group partners deciding together to get the most out of what they have;
- a key to a successful collaboration is honesty about what the partnership does and does not have, such as culture, history, companies, talent, etc.;
- an ambitious and specific vision will help create an idea that anyone can buy into and will last through stakeholder changes;
- the creation of short-, medium-, and long-term goals must be undertaken to communicate ongoing accomplishments and ensure long-term success; and
- the transformation of a former industrial area into a lively urban mixed-use centre in Zurich-West could be used as reference for Port Moody.

Dr. Lubik advised that the 2020 R&D Management Symposium: Invention to Innovation, Creating the Conditions for Impact is scheduled for August 4-5, 2020 and encouraged Committee members to register for the event.

The Committee noted that Port Moody's natural resources and history of high-value manufacturing are unique assets.

Dr. Lubik left the meeting at this point and did not return.

#### COVID-19 Business Impact Survey Results

- 4.2 The Manager of Economic Development provided an overview of the COVID-19 Business Impact Survey Final Results and the Breakdown of Top Four Responding Sectors and noted the following:
  - the results included the 24 new responses received since the last meeting, bringing the total number of respondents to 95;
  - the pandemic has provided the opportunity connect with many home-based businesses and provide tailored support based on their unique needs;

- the top four responding sectors were restaurants, breweries, and cafés, fitness and wellness, professional services, and retail businesses;
- the results provide a snapshot of the varying impacts of COVID-19 on the different sectors of Port Moody businesses:
- the impacts of COVID-19 may continue for an extended time for the fitness and wellness, and restaurants, breweries, and cafés sectors;
- the results revealed that a reliable source of personal protective equipment (PPE) was an area of concern for businesses and the City could explore ways to assist businesses in obtaining reliable sources of PPE;
- the survey results indicated that respondents were reluctant to take on more debt and had minimally participated in the support programs; and
- the survey results indicated that most respondents have support networks in place to assist with mental health challenges and that more than 50% of respondents were interested in further mental health and well-being resources; the City Could explore ways to provide assistance with mental health resources.

<u>Action</u>: The Chair and the Manager of Economic Development to review the Survey results and identify actionable items to meet the business community needs for the Committee's review at a future meeting.

re-opening of businesses with Mayors from across the Province
of BC. The Vice-Chair further advised that the Mayors will be
allotted two minutes each to comment on the state of economic
recovery in their respective communities and requested
Committee members' feedback on a message for
Minister Robinson.

The Committee members noted the following in response:

- the Canada Emergency Response Benefit program incentivizes employees to not return to the workforce and the money from this program could be better used at the Provincial or Municipal level to support infrastructure and programs which have suffered due to a lack of revenue; and
- the local businesses are concerned with patrons returning to previous consumer habits and not continuing to buy local after the pandemic; these businesses could benefit from assistance in strategies to retain customers.
