At the Special Council meeting held on May 12, 2020, Council considered the attached report dated April 6, 2020 from the Planning and Development Department – Policy Planning Division regarding Cannabis Retail Use Rezoning Applications – Second Round (**Attachment 1**) and passed the following resolutions:

THAT, as recommended in the report dated April 6, 2020 from the Planning and Development Department – Policy Planning Division regarding Cannabis Retail Use Rezoning Applications – Second Round, the following Bylaw be read a first and second time and referred to a Public Hearing:

- City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 35, 2020, No. 3250 (Site Specific Cannabis Rezoning 3034 St. Johns Street Cannoe); and
- City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 39, 2020, No. 3254 (Site Specific Cannabis Rezoning 2343 Clarke Street Happy Hippie Cannabis).

Bylaw No. 3254 was the subject of a Public Hearing on June 9, 2020 and was referred to the Special Council meeting held on the same date for consideration of third reading. Council gave third reading to Bylaw No. 3254 on June 9, 2020.

At the Regular Council meeting held on September 8, 2020, Council considered a memo dated July 31, 2020 from the Corporate Services Department – Legislative Services Division regarding Holding Additional Public Hearings (**Attachment 2**) and passed the following resolution:

AND THAT an additional Public Hearing be held for the consideration of City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 39, 2020, No. 3254 (Site Specific Cannabis Rezoning – 2343 Clarke Street – Happy Hippie Cannabis). City of Port Moody Zoning Bylaw, 2018, No. 2937, Amendment Bylaw No. 39, 2020, No. 3254 (Site Specific Cannabis Rezoning – 2343 Clarke Street – Happy Hippie Cannabis)—a Bylaw to amend the General Commercial (C3) zone to include one site specific Cannabis Retail Use location at 2343 Clarke Street—(**Attachment 3**) will be the subject of a new Public Hearing to be held on October 27, 2020. If referred from the Public Hearing, Bylaw No. 3254 would be before Council for consideration of third reading.
