

# City of Port Moody

### Bylaw No. 3288

A Bylaw to amend the Official Community Plan to City of Port Moody Official Community Plan Bylaw, 2014, No. 2955 to allow for increased building height and to change the land use designation on a portion of the site comprising 2102 and 2106 St. Johns Street, 2101 Clarke Street, and three vacant parcels from Mixed Use – Moody Centre to Parks and Open Space.

The Council of the City of Port Moody enacts as follows:

### 1. Citation

1.1 This Bylaw may be cited as "City of Port Moody Official Community Plan Bylaw, 2014, No. 2955, Amendment Bylaw No. 29, 2021, No. 3288 (2101 Clarke Street and 2102-2106 St. Johns Street)".

### 2. Amendments

- 2.1 The Official Community Plan Overall Land Use Plan Map 1 in Schedule "A" of City of Port Moody Official Community Plan Bylaw, 2014, No. 2955 is amended by changing the land use designation of the following lands from "Mixed Use Moody Centre" to "Parks and Open Space" as shown on the Location Map in Schedule A of this Bylaw:
  - PORTION OF LOT 20 EXCEPT: PART DEDICATED ROAD ON PLAN LMP19138, BLOCK 3 DISTRICT LOT 202 GROUP 1 NEW WESTMINSTER DISTRICT PLAN 55 (2106 St. Johns Street) PID: 003-991-318;
  - WEST HALF LOT 32 BLOCK 3 DISTRICT LOT 202 GROUP 1 NEW WESTMINSTER DISTRICT PLAN 55 PID: 003-991-474;
  - PORTION of LOT 19 EXCEPT: PART DEDICATED ROAD ON PLAN LMP19138, BLOCK 3 DISTRICT LOT 202 GROUP 1 NEW WESTMINSTER DISTRICT PLAN 55 (2102 St. Johns Street) PID: 003-991-253;
  - PORTION OF PARCEL B (BYLAW PLAN 50455) EXCEPT: PART DEDICATED ROAD ON PLAN LMP19138, BLOCK 3 DISTRICT LOT 202 GROUP 1 NEW WESTMINSTER DISTRICT PLAN 55 PID 013-589-717; and
  - PORTION OF LOT 33 BLOCK 3 DISTRICT LOT 202 GROUP 1 NEW WESTMINSTER DISTRICT PLAN 55 PID: 003-991-563




